1. The Candidates have to submit duly filled up (**Assam Gazette Part-IX**) **Standard Form** along with the following documents:
 - (a) Self attested copies of all Certificates, Marksheets in support of educational qualification, Computer Diploma/Certificate (Minimum 6 months), Age Proof Certificate, Employment Exchange Registration Certificate, Caste Certificate etc.
 - (b) 2 (two) copies of recent passport size photograph duly signed by the candidate on the reverse side.
2. The last date of receiving the offline applications is **25-08-2026** till office working hours.
3. The above-mentioned posts will be filled up by conducting a **Walk-in-Interview along with a typing test**.
4. The list of candidates provisionally allowed for appearing in the Walk-in-Interview/ Typing Test and the list of rejected candidates will be notified in the notice board of this office on **26-08-2026 at 4 P.M.**, after proper scrutiny of the applications submitted by them.
5. The candidates who were provisionally allowed for appearing in the Walk-in-Interview & Typing Test, vide earlier Advertisement & Notification No. FT/CHR-39/2026/97 dated 03-8-2026 and No. FT/CHR-39/2026/102 dated 11-8-2026 respectively, need not apply again. They shall directly appear on the date of Walk-in-Interview & Typing Test which shall be notified later in the notice board of this office.
