2. Interested vendors/individuals should inspect the petroleum products on any day from 05/07/2023 to 09/07/2023 between 11:00 A.M. to 4:00 P.M. which are stored at Kajalgaon P.S. premises, Kajalgaon, Chirang to ensure quoting of proper bid value proposals.
3. Submission of bid/tender shall open from 05/07/2023 at 10:00 A.M. to 12/07/2023 up to 3:00 P.M. and bidder have to submit quotation along with relevant documents in the drop box at the office of the undersigned. The Drop box will be opened on the same day at 4:00 P.M. in presence of the bidder/representative of bidder.
4. The bidder who quotes the highest value shall be considered for selection subject to fulfillment of other conditions.

The successful bidder will be required to deposit the final value of the sold petroleum products through treasury challan in the refundable Head of the Govt. within 5 (five) working days from the date of auction and for default, will attract cancellation of the contract and in such event an opportunity will be given to the bidder quoting next higher rate (2<sup>nd</sup> highest bidder) provided he/she agrees to accept the prices offered by the highest bidder.
