3. The quotation box will be opened on 29th November, 2023 at 03:00 PM in presence of the bidders or their authorized representatives.

Interested bidders should inspect the seized rice items in consultation with the Deputy Director, Food, Public Distribution & Consumer Affairs Department, Chirang on any day w.e.f. 9th November, 2023 to 29th November, 2023 between 11:00 AM to 3:00 PM which are stored at Basugaon Trading Co-operative Society, Basugaon Town, Chirang and quote their rates appropriately..

The successful highest bidder will be required to deposit the final value of the seized rice item through treasury challan in the refundable Head of the Govt. account within 5 (five) working days from the date of auction, failing which will attract cancellation of the contract and in such event an opportunity will be given to the bidder quoted next higher rate (2nd highest) bidder.
6. The successful bidder shall lift the seized rice within 5 (five) working days at his/ her own cost and risk after making full payment of the bid amount, failing which the committee shall not be held responsible for any damage or loss to the goods thereafter.
