The sealed tender will be received by the office of the District Commissioner & District Election Officer, Chirang up to 08/03/2024 of 12:00 PM and will be opened at 1:00 PM on the same day in presence of quotationers or their authorized agents.

TERMS AND CONDITIONS:


1. The quoted rate should be below 10% of estimated amount of the electrification works and should be inclusive of all admissible taxes i.e. IT, GST etc. as per communication letter received from the CEO, Assam, vide No. ELE-111/2023/21 Dtd 1/12/2023.
2. The tender papers should invariably enclose copy of registration certificate /Trade License, GST registration certificate, PAN Card, Labour Registration Certificate, 3(three years Income Tax Returns with the quotation. Quotation without said documents will be rejected.
3. In case of the rate quoted by the tenderer is found to be below/higher from the estimated amount of the works, the undersigned reserves the right to cancel his quoted rate against the works without any notice served upon him though his rate seems to be lowest/highest.
4. The tenderer should have to deposit 2% security money (1% in case of ST, SC, OBC contractors) of the total value of the works in form of Cheque in favour of Deputy Commissioner, Chirang (Election).
5. Payment will be made subject to availability of fund in the respective head of account after observing of all formalities of financial rules thereof. No claim as regards to

payment etc. will be entertained if fund in the concerned head is not received from the Govt.

6. Rate should be quoted both in digit and words by the quotationer .
7. If the party is unable to construct the works /electrification at its accepted rate, the security money will be forfeited.
8. The undersigned reserves the right to accept or reject any or all quotations without assigning any reason thereof in public interest.
