1. Construction of pandals for Medical Team (12 feet X 12 feet), Media Persons (12 feet x 12 feet), Cultural Troupes (30 feet x 10 feet) and public (60 feet x 20 feet).
2. Decoration of gates (2 Nos.) with tricolor cloth/ flags/ balloons.
3. Balloon and floral decoration of flag unfurling platform.
4. Balloon and floral decoration and furnishing of the dais with tricolor cloth.
5. Providing 30 (thirty) No. office chairs, 06 (six) No. sofa sets along with 06 (six) No. centre tables and 1000 (one thousand) No. plastic chairs.
6. Providing sound system.
7. Printing and providing banner (03 Nos.), invitation cards, certificates etc.
8. Providing 1000 Nos. packed light refreshment containing one piece each of (1) Narikol Ladoo (2) Til Ladoo (3) Sukan Pita (4) Boiled Egg (5) Kachuri and (6) 200 ml. packaged drinking water.

4. Rates once quoted and accepted shall be final and no alteration/ modification of the same shall be allowed thereafter.

5. The successful quotationer must be in a position to supply the items/ execute the works immediately on getting order from the O/o the undersigned.
6. In the event of any defect/ deficiency detected after the items supplied/ works completed, the concerned firm/ supplier/ vendor/ contractor/ individual etc. shall have the rectify the same at his/ her own cost.
