In continuation of this office earlier NIT issued vide No. Ch-Health/01/2023/14-A dated 30th of March, 2023, sealed tender affixing non-refundable court fee stamp of Rs. 8.25 (Rupees eight and paise twenty five) only is re-invited from the intending registered firms, suppliers, vendors, contractors, individuals etc. for doorstep delivery of the following nutritional support to the TB patients under Pradhan Mantri TB Mukta Bharat Abhiyan.

Taking into consideration the necessity to provide the nutritional support to the TB patients on an urgent basis the duration of the SNIT is minimized to 03 (three) days only in the interest of larger public services.

The sealed tender can be dropped in the tender drop box placed in the O/o the undersigned w.e.f 01 June, 2023 to 03 June, 2023 up to 02:00 PM. The sealed tender box will be opened on the same day i.e 03 June, 2023 at 03:00 PM in presence of the tenderers or their authorized representatives.

Terms & Conditions:

1. Earnest Money of Rs. 1,000.00 (Rupees one thousand) only by way of Demand Draft/ Call Deposit in favour of the Deputy Commissioner, Chirang will have to be deposited by each tenderer along with the tender. This will be refunded to the unsuccessful tenderer within 7 (seven) working days.
2. An agreement pertaining to fully execution of the work is to be signed between the successful tenderer and the Deputy Commissioner, Chirang. Also sum of Rs. 16,000.00 (Rupees sixteen thousand) only is to be deposited by the tenderer as Security Deposit by way of Demand Draft/ Call Deposit in favour of the Deputy Commissioner, Chirang.
3. The Security Deposit money of the successful tenderer will be returned after successful completion of the work. The same will be forfeited in the event of non-fulfillment of the terms & conditions or by the successful tenderer.
4. Maximum rate for the above items per TB patient per month including transportation cost for doorstep delivery should not exceed Rs. 500.00 (Rupees five hundred) only.
5. Sample of each item is to be provided along with the tender as follows:

6. The rates quoted should be inclusive of all admissible taxes i.e. GST/ IT etc.
7. The tenderer should invariably enclose copy of firm registration/ supply registration/ contract registration certificate, copy of GST registration certificate, copy of up to date GST/ IT return acknowledgement, copy of PAN card, copy of trade license etc. Tender without valid documents will be rejected forthwith.
8. Rates against each item should be written or typed properly in digit and words. In case of any correction, the quotationer should put his signature.
9. Rates once quoted and accepted shall be final and no alteration/ modification of the same shall be allowed thereafter.
10. The successful tenderer must be in a position for doorstep delivery of the above items by 8th of each month.
11. Tender submitted/ sent through Fax/ e-Mail/ Whatsapp etc. shall not be accepted.
12. The sealed envelop should be super-scribed in bold capital letters as 'PROVIDING NUTRITIONAL SUPPORT TO TB PATIENTS' on its top and can be dropped in the tender box placed in the O/o the undersigned w.e.f 24th March, 2023 to 13th April, 2023 during office hour up to 03:00 PM.
