Applications are invited in prescribed formats from interested candidates for filling up positions lying vacant in CWC and JJB, Chirang

# Required Qualifications

- 1. Age- 35 to 65 years as on 01/01/2024
- 2. Educational qualification- a degree in child psychology, psychiatry or law or Social Work or sociology or Human Health or Education or Human Development or Special Education for Differently Able Children. Preference will be given to the Post Graduate in the mentioned subject.
- 3. Experience- Actively involved in Health, Education and Welfare Activities pertaining to children for seven years or is a practicing professional with the above mentioned degrees
- 4. A person shall not be eligible for selection as a member of the Board/committee, If he/she--
- a) has any past record of violation of human rights or child rights;

- b) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed, has not been granted full pardon in respect of such offence;
- c) has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;
- has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.
- e) Is a part of management/ associated (directly/indirectly) of Child care institutions in a district.

(5)Existing Member of the Committee/Board should not apply for the same position. But a Member of the Committee/ Board can apply for the position alternatively.

- (6) The appointment of any member of the Committee/Board shall be terminated by the Government after making an inquiry if he/she -
  - (a) has been found guilty of misuse of power vested under this Act;
  - (b) has been convicted of an offence;
  - (c) fails to attend the proceedings of the Board/committee consecutively for three months without any valid reason; or fails to attend three-fourths of the sittings in a year; or
  - (d) holds such fulltime occupation that does not allow him to give necessary time and attention to the work of the Committee or the Board
  - (e) does not fulfill the qualification and experience prescribed in the Act and rules made there under and in such a case the selection Committee, constituted under Rule 87 shall after due inquiry and on establishment of such fact, reject his/her application and recommend the name of the next person from the list of names prepared for filling the vacancies.
  - (f) if any lawyer selected for any of the positions of Board or Committee, he/she shall be debarred from dealing any cases relating to child (below 18) during his tenure of CWC or JJB.
  - (g) All selected Members shall have to submit their police verification report.

The Chairperson and/Members , Social Workers/members (CWC/JJB) shall be paid as per Mission Vatsalya norms only per sitting ( minimum 6 hours in a day)as travel, sitting & conveyance allowance.

Applicants shall submit applications along with a self declaration certificate by 25th January 2024 during office hours in the office of the District Child protection Officer, Chirang. Copy of self declaration certificate is attached with the advertisement.

The applications received shall be scrutinized by District Level Scrutiny Committee (DLSC) and the panel list of shortlisted candidates shall prepare at the ratio (1:3) and placed before the State Level Selection Committee (SLSC), constituted under Rule 87 of Central Model JJ Rule, 2015 for the final approval. The SLSC has the power to reject any applications and received recommendations given by DLSC as and when required. If SLSC receive any complain against any recommended candidates of DLSC, the SLSC may review their recommendation.
