Minutes of the DC's Conference held on 18th September, 2018 relating to the Finance Deptt's schemes.

Hon'ble Chief Minister, Assam chaired a meeting of the Deputy Commissioners of all the districts of Assam on 18th September, 2018 at Assam Administrative Staff College, Khanapara, Guwahati in the presence of the Hon'ble Finance Minister, Chief Secretary, Additional Chief Secretary, Finance and other Senior Officers. In the meeting, the following decisions were taken regarding the implementation of the Chah Bagicha Dhan Puraskar Mela and Axom Adarxo Gram Yojana:

(A) Chah Bagicha Dhan Puraskar and Suraksha Yojana:

Phase I

- i) It was reported by some DCs that there was some amount out of the sanctioned amount for the 1st Phase which are lying with them. They cited many reasons for their inability to transfer these funds, this ranging from wrong account number, wrong IFSC code, wrong names of beneficiaries, KYC issues etc. The Hon'ble Finance Minister categorically mentioned that the Deputy Commissioners should make every effort to ensure that no genuine beneficiary is denied the benefit under the scheme due to 'technical reasons'.
- ii) It was decided that the DCs will immediately compile this information in a format to be circulated by Finance Department and then resolve the issues at the earliest.
- iii) Data re-verification is to be done by the DCs alongwith Tea Garden Management, LDM etc before end October.
- iv) Hon'ble Finance Minister urged the DCs to ensure that no bank accounts opened during this period fall into disuse/become inactive. DCs were urged to use Voter Identity card of workers as required KYC document for verification by the banks.

Phase II

- i) Hon'ble Finance Minister opined that the whole idea of Chah Bagicha Dhan Puraskar Scheme is to ensure that all eligible beneficiaries are covered under the scheme.
- ii) Hon'ble Finance Minister urged the DCs to submit a separate list for such accounts that were opened before demonetization but due to various reasons were left out of the Phase I of the implementation. The Finance Department as a special case will sanction a total of Rs.5000/- each for those workers.
- iii) Sanction, 'guidelines, etc. for Phase II. will be issued by the Finance Department by 30th November/2018.
- iv) Hon'ble Finance Minister also asked the DCs to submit separate a list with proper justification to the Finance Deptt. for the workers who opened their bank account after 31st May. 2018 (cutoff date as per earlier notification) which will be examined by the Finance Department and decided on a case to case to basis.

(B) Axom Adarxo Gram Yojana:

i) Hon'ble Finance Minister also directed the Deputy Commissioners to immediately select 2 villages in each Constituency in consultation with their local MLA to be developed as 'Adarxo Gram' and communicate the same to Transformation and Development Department within 10th October.

- ii) It was also clarified that the villages to be selected under the 'Adarxo Gram' would mean Revenue Villages
- iii) Hon'ble Chief Minister and Hon'ble Finance Minister insisted that the 'Adarxo Gram' Yojana offers the Deputy Commissioners a wonderful platform to transform the face of the villages being chosen in their districts and urged them to use this opportunity to leave a lasting impact on the village/district.
- iv) Hon'ble Finance Minister also urged the Deputy Commissioners to identity some 'entry point' activities in these chosen villages like Upgradation of Higher Secondary Schools. Redevelopment of Anganwadi Centres, Reconstruction of Primary Health Centres etc to be executed in this Financial Year.
- v) Detail guidelines of the scheme will be showed in due course of time by the Transformation & Development Department.
